Dear Sir:

This is to inform you that your compensation claim has been carefully reviewed under Public Act 458, 79th Congress, which authorized a new rating schedule for evaluating disabilities.

The application of the new rating schedule caused no change in the evaluation of the degree of disability. Consequently, no change in monthly compensation payments resulted from this review.

If there is evidence available to you which in your opinion would warrant a different decision, such evidence should be immediately submitted to this office for reconsideration of your claim. If you have no further evidence to submit, but have substantial reason to believe that the decision is not in accordance with the law and the facts in your case, you may appeal to the Administrator of Veterans Affairs at any time within one year from the date of this letter. In the event you feel that appellate consideration is justified, further correspondence relating to the matter should be addressed to this office.

If you should change your present address, you should notify this office at once. All future communications with reference to this claim must show your full name, correct address and the C-number shown above.
