Chapman To Host Debate on Props. 74-77 on Oct. 25

Business and Media Representatives, Union Advocates and Elected Officials Will Debate Gov. Schwarzenegger's Reform Agenda in Event Moderated by KOCEs Ed Arnold

ORANGE, Calif., Oct. 19, 2005 As the battle for political power in California escalates, key advocates representing a spectrum of positions on the upcoming statewide ballot measures will debate the pros and cons of Propositions 74 through 77 at Chapman University on Tuesday, Oct. 25. There will be a reception with hors doeuvres and coffee at 5:30 p.m., with the debate immediately following from 6 to 8 p.m. in 404 Beckman Hall on the Chapman campus in Orange. Admission is \$25 for the public, with free admission for Chapman students, faculty and staff with valid IDs. The event is presented by the Chapman University Department of Political Science, the Chapman University School of Education and AeA Orange County Council.
