Dear Mr. Temianka:

I am now a resident of Aspen and have fallen under its spell, even with the snow.

I'm addressing this to Beverly Hills, as undoubtedly you will soon be there and I don't know where else to reach you. I received a recommendation about a student from Mr. Rosseels and have written her. For you, besides Helen Wells from Ft. Worth, Texas, I have a letter from Miss Betty A. Burns, from Clear Lake, Iowa,

and from Mr. Dallas Tjaden, whom I remember you spoke of. He asks about the G.I. Bill. I will inform him that it cannot be used.

There is a great deal of interest in the summer school. We are getting lots of requests for information.

I am enclosing application blanks for it is important that you contact the students you would particularly like to have in your class, recommending those that you advocate for scholarships. At this time we have very few scholarships, but I am starting to work on this and hope to have good results. The scholarship students should, for the most part, be able to pay their board and room for there aren't enough jobs to go around for students who want to earn part of their living expenses.

We have had a decision from Denver that the G.I. approval is not possible for Aspen this summer.
