### Grossmann and Hopkins' – Ideological Republicans and Group Interest Democrats

"The Republican Party is best viewed as the agent of an ideological movement whose members are united by a common devotion to the principle of limited government." "In contrast, the Democratic Party is properly understood as a coalition of social groups whose interests are served by various forms of government activity."



# Hypotheses

H1: College Democrats will align more with Grossmann and Hopkins' theory, while College Republicans will not H2: College Republicans will be less focused on the principle of limited government and more focused on (1) promoting the Republican Party, (2) criticizing the Democratic Party, and (3) commenting on specific issues and topics

**H3:** The two groups will remain asymmetrical, albeit for slightly different reasons than those put forth by the theory in question

# A Look at the Literature

### **Collegiate Politics**

- College Republicans and College Democrats have received little attention in the scholarly realm
- College and Young Republicans have been the preferred subject of study (i.e., Kidder, 2016; Nokleby, 2019)
- An individual's time in higher education is highly influential, especially in terms of political identity and engagement (i.e., Perrin and Gillus, 2019)

### **Political Socialization**

- Scholars have written extensively on the concept of political socialization
- An individual's youth, particularly between the ages of 14 and 25, are incredibly influential (i.e., Niemi and Hepburn, 2010)
- There is debate over the primary forces of political socialization, especially as it pertains to higher education

### **American Political Parties**

- Original literature on American political parties suggests they have similar characteristics and are symmetrical
- This style of thinking has been countered by scholars who claim each party has distinctive identities and characteristics (i.e., Grossmann and Hopkins, 2015; Galvin, 2010)
- Few, if any at all, have applied this thinking to college political organizations

# Methods

- Content analysis of College Republican and College Democrat social media
  - Analyzing ten most recent substantive Instagram posts
- Examining both organizations at twenty total schools (controlled by region and public/private)

Limitations:

- Not all organizations have active Instagrams
- Social media posts do not always reflect all views or beliefs of all members
- Coding is a semi-subjective process



# **Coding Process**

- Includes advocacy for a specific issue, specifically one that includes "the principle of limited government"? (Y/N)
- Includes advocacy for a specific issue, specifically one that includes "forms of government activity" that serves a "social group"? (Y/N)
- Includes advocacy for or against a specific issue that does NOT include "the principle of limited government" or "forms of government activity" that serves a "social group"? (Y/N)
- Includes advocacy for or against a particular ideology? (Y/N)
- Includes advocacy for or against a particular political figure or candidate? (Y/N)
- Includes advocacy for or against a particular party? (Y/N)
- Includes advocacy for a particular "social group" or demographic? (Y/N)
- Includes advocacy for or against campus policies or politics? (Y/N)
- Other Comments: (open-ended)

# Includes advocacy for a specific issue, specifically one that includes "the principle of limited government." (Y/N)

Organization	Percent of Posts
College Republicans	14%
College Democrats	1.5%

- Very few College Republican organizations shared posts promoting "the principle of limited government"
  - When sharing such posts, the organizations often allude to broad notions of freedom and liberty, rather than specific issues that promote limited government
  - In fact, many organizations promoted issues that increased the role of government (i.e., support for law enforcement and abortion restrictions)

College Democrats	23%

- While more College Democrat organizations promoted "forms of government activity that serve a social group" than College Republican organizations promoted "the principle of limited government," the number is NOT substantial
  - Nevertheless, common themes include advocacy for women, the Black community (especially after the murder of George Floyd), the LGBTQIA+ community, the working class, and others

#### Call for Solidarity with Agitators and Protesters

To the UCLA community and beyond.

There are few words that can adequately encapsulate our anger and frustration at the state of America today. On May 25, 2020, yet another life was taken by the scourge of anti-Black police violence. George Floyd, 46, was murdered by a white police officer in cold blood, with three other police officers also involved.

Black lives matter. All Democrats, Republicans, progressives, Bruins, white Americans, and non-Black people of color must be in solidarity with our Black communities on campus and beyond. It is incumbent on political organizations such as ours to fight so long as systems of oppression continue to threaten the lives of Black people everywhere.

Some might see it fitting for us to focus on the disgusting and incendiary response of our current president. His response was grievously disappointing, and not at all surprising. But it would be inappropriate for us not to address the role of white liberals in stoking police violence-white liberals like Amy Cooper, who on Monday morning called the police on Christian Cooper, a Black man who was bird-watching in Central Park. In the case of non-Black people of color who have yet to address the anti-Blackness in their communities too, passivity contributes to oppression. As Democrats, we must continuously push ourselves to realize and acknowledge that, as people who claim to be supporters of social justice, our party and its supporters still play a role in the systemic inequality that has cost individuals like George Floyd their lives. After all, Amy Cooper supported numerous Democratic candidates in the past. Democrats are and have been complicit.

Accordingly, we are committed to holding ourselves and our political allies accountable just as much as our adversaries. As an organization, we choose to align ourselves with the wide array of leftist campus organizations in solidarity with agitators and protesters at this time. We stand with members of the UCLA community in mounting a challenge to UCPD and other demonstrably anti-Black institutions in our community. We stand with the Black youth-led movements that demand justice and accountability. We must do our part to work alongside those who seek a better future for the Black community both on campus and nationwide.

Dear President Michael Crow and the Arizona Board of Regents

Among many other anti-abortion bills this session, a particularly dangerous and catastrophic bill called SB 1457 (the forced birth bill) has been introduced in Arizona. It is a blatant attack on reproductive freedom, criminalizing healthcare by threatening physicians and women (or any individuals pursuing reproductive healthcare) with jail time. SB 1457 is sweeping and purposefully vague in language to tie the hands of physicians and impose countless limitations. As of right now, the bill has passed both chambers and is headed to Governor Ducey's desk. Immediate action needs to be taken to halt this bill.

If signed into law by Governor Ducey, SB 1457 would

- · Make abortions due to a "genetic abnormality" (such as a fatal fetal diagnosis) a CLASS 3 FELONY · Grant personhood rights to fetuses (require fetal remains to be cremated or buried)
- These actions would in turn:
- · Traumatize, shame, and endanger patients
- Spike the rates of UNSAFE abortions

44% of the students at your institution are women (U.S. Department of Education). As proudly displayed on the ASU website. 48% of the faculty at your institution are women. The consequences of this bill would especially endanger and jeopardize the health of the community of women at your university. 40.9% of women who have abortions are college educated; 45.5% of abortions are performed on college-age women (<20 to 24) (guttmacher.org). Historically, fetal personhood laws in other U.S. states reap devastating repercussions on young, poor, women of color, who are most often targeted with persecution under these bills. 48% of the students at your university are BIPOC (U.S. Department of Education). We stress that ASU students would be thrown in jail for pursuing healthcare under this bill. Young women would also inevitably resort to pursuing unsafe abortions, risking complications and death.

Not to mention, this bill ties the hands of physicians and OB-GYN residency programs. Arizona medical students would have to go out of state to pursue residency training. This bill would also halt important research being done. SB 1457 would discourage medical students from bringing their talent to ASU and other top schools in the state.

ASU champions gender and racial diversity. The young women and young women of color that choose to bring their talent to ASU deserve the advocacy of Michael Crow. This is not political or controversial: this is a public health issue. The lives and health of the women who attend your university and the women who work for your university are in immediate danger. You have a responsibility to use your leverage and power as the President of this major institution to speak up against SB 1457. A salary of \$1.5 million seems well sufficient to expect advocacy for half of your students and faculty (Chronicle of Higher Education).

Abortion is safe, legal, and essential health care. We demand that ASU as an institution takes action and breaks the silence immediately. This is not a matter to be taken lightly. We urge other student organizations on campus to demand that Michael Crow addresses the dangers of SB 1457. We also urge student organizations at NAU and the U of A to draft letters to their respective Presidents and the Arizona Board of Regents.

  - <u>College Republicans:</u> Examples include commenting on the 2020 election and immigration issues under Joe Biden
  - <u>College Democrats:</u> Examples include commenting the impeachment of Donald Trump and academic freedom violations





# **Conclusions and Looking Ahead**



- Preliminary findings suggest neither College Republicans nor College Democrats fit directly within Grossmann and Hopkin's theory
  - <u>However</u>, initial findings showcase the asymmetrical nature of the two major American political parties and, thus, confirm part of the Grossmann and Hopkins theory
- Looking ahead, further research should...
  - Build upon this content analysis with other research techniques (i.e., surveys or interviews with students) to garner a more holistic understanding of these organizations
  - Analyze a larger and more randomized sample to obtain more representative and generalizable findings
  - Examine the specific techniques employed by both organizations to share and promote their respective beliefs
