Dear Mr. Temianka:

I have approved the recommendation of your appointment as Professor of Music for the academic year, September 14, 1964 to June 12, 1965, at a salary rate of \$10,908 per year, or \$909 per month.

The initial salary is based upon the information concerning your preparation and experience available to us at this time, and is subject to withholding, retirement, and Social Security deductions.


It is understood that, due to prior concert commitments, you will need to be away from the campus during a ten day period in October, and at varying times during a six weeks period in January and February. Under State regulations it will be necessary that you be in a leave without pay status during such absences.

It will be necessary for you to complete, in duplicate, the form SC-1 which is enclosed. A condition of employment is that you subscribe to the State Loyalty Oath to be administered at the time of entrance on duty. Also, at that time you will be expected to furnish your Social Security identification number, and to complete additional payroll documentation in the Personnel Office, Room 200, Administration Building.

This, like all initial appointments, is for one year. State College regulations provide that when the initial appointment is made at the rank of Professor, tenure may be gained on beginning a second consecutive year and shall be gained on beginning a third consecutive year of service unless such a year is a terminal notice year.

Will you please let us know whether this offer is acceptable to you. An early reply, together with the enclosed form, would be most helpful.
