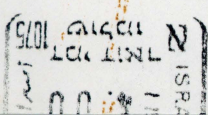

The following is the translation of the newspaper article that appeared in the Swedish newspaper AFTONBLADET, Tuesday December 21, 1982.

He saw his mother and sisters die in Auschwitz. "I am here to defend myself and the honor of my family," said Mel Mermelstein. "When I was 17 years old my family and I were sent to the concentration camps Auschwitz-Birkenau and later to Gross-Rosen and Buchenwald." He has seen with his own eyes, his mother and two sisters taken to the gas chambers. He remembers the arrival at the concentration camp, when the prisoners were forced to undress and were chased by the SS troops, some were driven into the pits and burned alive. Mel Mermelstein writes about that in his book BY BREAD ALONE.

Some time ago he got a letter from Sweden postmarked Täby, outside Stockholm. The letter contained anti-Jewish information, with hair and soap noted "made of pure Jewish fat." Mel Mermelstein was one of twelve picked to get such a letter, and yesterday Mermelstein was one of the twelve who met in the courthouse with Felderer.

#### JOURNALISTS INVITED

The 40 year old was brought in handcuffs to the Court of Södra Roslags. It is the first time a person had been arrested for such a crime in Sweden. The courtroom was filled to capacity and radio, T.V. and newsmen got personal invitations so they could participate in the case.

When the defense attorney Klas Kanegård turned to the judge and said, "My client only disputes," the 40 year old in a high voice said, "It is not true. I do not want a defense lawyer." District Attorney Torsten Jonsson spoke about the unfriendly Jewish propaganda the 40 year old has mailed to persons the world over. He is accused of, among other things, having left the propaganda at the Royal Library in Stockholm, to a lady in Germany, to the High Court in Canada and to the Anne Frank Society.

Many times the accused got into a long speech and more than once the judge had to tell him to be quiet. When he at last got to speak again, he insisted that he was a Jew himself and was a refugee from Austria who came to Sweden with his mother.

When the accused talked about concentration camps, Mel Mermelstein left the court room. After a long speech by the 40 year old, the judge stopped him. The Court found him guilty. He is to go through psychiatric examinations and then it will be decided if he is to go to prison or the psychiatric ward.

The following is a translation of the newspaper article that appeared in the Swedish newspaper DAGENS NYHETER., Tuesday December 21, 1982.

RE: FELDERER (THE 40 YEAR OLD FROM TÄBY)

The 40 year old from Täby, who is accused for spreading hate against the Jewish people, will be tested next Monday by a psychiatric panel for his mental condition, so ruled the court of Södra Roslags.

District Attorney Torsten Jonsson also accuses the man for printing flyers with hate against Jews. He glued animal hair and soap, as that of hair from Jews gassed in the concentration camps and the soap as "Pure Jewish Fat," on the flyers.

He sent flyers and letters to Jewish organizations the world over. Swedish diplomats have protested in many countries, and West Germany, through diplomatic channels, had asked Sweden to take court action against the man.

The 40 year old avoided answering most of the questions as he was asked for a simple "yes" or "no" to which he would not agree. The judges warned him several times. He would not admit to having printed and mailed the letters containing the hair, etc...

The 40 year old was born in Austria and both parents were Jewish, so he stated. His mother and he came to Sweden in 1949. The man said he was harassed in the schools. In 1970 he joined the Jehovah's Witnesses to ask if it really was true that tens of thousands died in the gas chambers in World War II.

Since then, the 40 year old used all of his time to fight what he called "Zionism." He claims the Jews in Israel and the world over are not recognized as a group of people, and that the concentration camps never existed, except as recreation camps with horse races, swimming pools and other leisure equipment. "Concentration camps and gas chambers are an invention of the international Zionists to justify the removal of the Palestinians," he said.

The 40 year old said he lived on his wages as a part time bus driver (two days every two weeks of work). Though he could afford to go to the United States and Poland on many occasions over the last years. Many expensive articles and a complete business office was found in his home. The prosecutor assumed that he must have economic help from the outside, otherwise it would have been impossible for him to print and mail so many flyers and letters.

The accused got plenty of time from the judge to report on the background of the propaganda he has been involved with for many years. He turned to the audience rather than to the judge to deliver his propaganda speech. The 40 year old claims to belong to an international organization of "revisionists" who want to change the historical picture of the Jews in Hitler Germany.

One witness the accused did not want to hear was sitting in the court room. One man who could report about how it was in the concentration camps. Mel Mermelstein, now living in the United States, was taken to Auschwitz on May 21, 1944, at only 17 years of age. He alone survived, his parents and sisters did not. The accused had also sent Mermelstein letters with hair glued on the drawing. Mermelstein made a good speech against the man later.

J. K. is going to decide if the man has violated the freedom of the press in the near future.

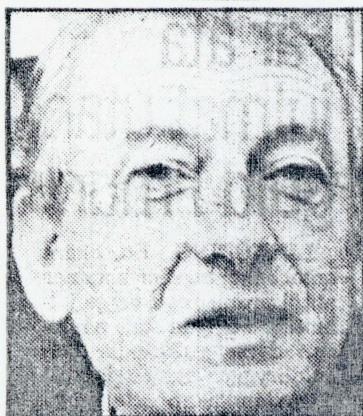

**STOCKHOLM.** – Auschwitz var en idyll med swimming-pool och underhållning, sa den 40-årige mannen i rätten i går. Då reste sig Mel Mermelstein från Los Angeles och gick ut ur rättssalen. Han var bara 14 år gammal när han såg sin mor och sina två systrar föras in i gaskammaren. Nu är han i Sverige för att lyssna på rättegången mot 40-åringen som skickat judefientlig propaganda till honom.

– Jag är här för att försvara min egen och min familjs heder, sa Mel Mermelstein, 56, i går i en paus under rättegången.

## Såg mor och systrar dödas i Auschwitz

### I går mötte han judehetsaren från Täby i rättssalen

När han var 14 år gammal fördes han och hans familj till koncentrationslägret Auschwitz-Birkenau, senare till Gross Rosen och Buchenwald. Han såg med egna ögon hur hans mor och två systrar fördes in i gaskammaren. Han minns ankomsten till koncentrationslägret när fångarna tvingades klä av sig och sedan jagades av SS-trupper och hundar nedför vägen mot tre eldar. Männen tvingades springa runt eldarna fortare och fortare. En del drevs in i lågorna och brändes levande till döds. Mel Mermelsteins skräckminnen är samlade i hans bok "By Bread Alone".

För en tid sedan fick han brev från Sverige, poststämplat i Täby utanför Stockholm. Kuvertet innehöll judefientlig information med en tvålbit och en hårtuss klistrade

på papperet.

"Detta är rent judefett, med lukt från ungerska judar", löd texten. Mel Mermelstein från Kalifornien är en av de 12 personer som fått brev från 40-åringen i Täby.

I går möttes de i rättssalen.

### Journalister inbjudna

40-åringen fördes i handbojor till Södra Roslags tingsrätt. Det är första gången en person anhålls och häktas för brott som "hets mot folkgrupp".

Rättegången var ovanlig på många sätt. Åhörarbänkarna var fyllda till sista plats och mannen hade personligen "inbjudit" journalister från tidningar, radio och TV att delta i rättegången.

När försvarsadvokat Klas Kane-

gård vände sig till rätten och sa:

"Min klient bestrider brott", protesterade 40-åringen högljutt.

– Det stämmer inte. Eftersom jag har avslöjat sionism och detta är ett brott i Sverige, så erkänner jag brott. Så är det. Dessutom vill jag inte ha någon försvarare. Länsåklagare Torsten Jonsson redogjorde för den judefientliga propaganda som 40-åringen skickat till personer världen över. Han anklagades bland annat för att ha spridit propagandan på Kungliga biblioteket i Stockholm, till en kvinna i Tyskland, till justitiekanslern, till en judisk kongress i Kanada och till Anne Frank-stiftelsen.

Varje gång åklagaren ställde en fråga började 40-åringen med långa utläggningar. Flera gånger knackade domaren otåligt med

ordförande-klubban och bad mannen hålla tyst.

När han slutligen fick ordet igen ställde han sig upp och vände sig med lysande ögon mot åhörarna istället för mot rätten. Mannen påstod att han själv var jude och kom som flykting från Österrike tillsammans med sin mor.

När 40-åringen talade om koncentrationslägren reste sig Mel Mermelstein och gick ut ur rättssalen. Efter en lång slutplädering avbröt domaren den ivrige 40-åringen. Rätten drog sig tillbaka och meddelade efter en stund att mannen var skyldig. Han ska dock genomgå en rättspsykiatrisk undersökning innan det avgörs om han får fängelse eller sluten psykiatrisk vård.

## Rasisten: Jag blev förföljd i skolan

Han nekade i går inför rätten till att ha sänt tvålbiter märkta "äkta judefett" till olika judiska organisationer.

Clüver-Felderer sa att han inte hade skickat de brev länsåklagare Torsten Jonsson visade vid gårdagens rättegång.

Breven var försedda med hårtussar och bitar av tvål, flera i kuvert som först var adresserade till Clüver-Felderer i Täby.

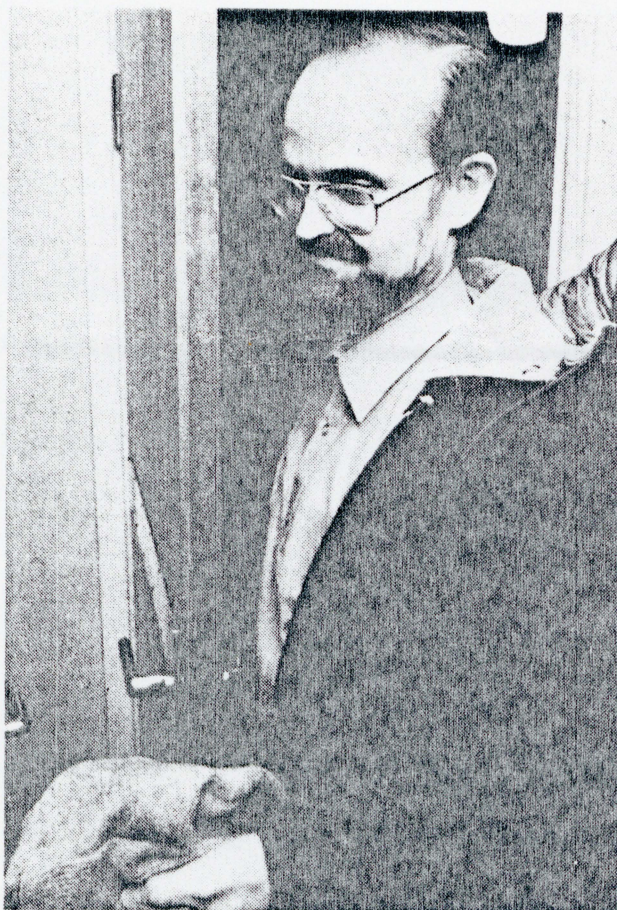
Men Clüver-Felderer framhöll också att han tycker det är "horribelt och absurt" med en rättsprocess om tvålbiterna:

– Det var sionisterna själva som började skämta om tvålarna redan i lägren, sa han.

Clüver-Felderer fortsatte med att kalla Auschwitz och andra koncentrationsläger för judarnas rekreationsläger med simbassäng, teater och bordeller.

Då yrkade åklagaren att tvål och hårtufsar som hittats hemma hos Clüver-Felderer skulle tas i beslag.

Och lagman Michael von Koch och nämnde-

männen kom efter en ganska kort överläggning fram till att Clüver-Felderer ska genomgå den stora rättspsykiatiska undersökningen.

Fyrtioåringen ägnar sitt liv åt att bekämpa sionismen. Och han kör ibland buss åt SL.

I hans lägenhet i Täby trängs offsetpressen en elskrivmaskin, flera

bandspelare och buntvis med papper. Där finns mängder av skrifter som hävdar att inga judar dog i nazisternas koncentrationsläger.

Skrifterna han skriver och sprider ska också upp i rätten, i ett tryckfrihetsmål. Förundersökningen har just börjat.

Ditlieb Clüver-Felde-

rer är själv jude. Han kom med sin mor till Sverige 1949.

I går fick han tillfälle att berätta varför han sprider skrifterna:

– Jag förföljdes i skolan. Jag tog alltid indianernas parti när vi lekte indianer och vita. Och jag började tidigt undra om vår historieskrivning var den rätta.

På 1970-talet började han så tvivla på gas-kamrarna. Han lämnade Jehovas vittnen. Och hans kamp mot sionismen startade:

– De använder gas-kamrarna som ursäkt för att terrorbomba palestinierna, sa Clüver-Felderer i går.

Domaren och nämndemännen ansåg att han skulle fortsätta hetsa mot judarna om han släpptes. Och Clüver-Felderer får sitta häktad tills han är undersökt.

Därefter kan han dömas till högst två års fängelse. Om inte behandlingen blir sluten psykiatrisk vård.

Åhörare vid rättegången i går var Mel Mermelstein, en av dem som tagit emot brev med tvålbit och hårtuss. Han hade rest till Södra Roslags tingsrätt från Kalifornien, USA.

– Enda sättet att stoppa en rasist som Felderer är att sätta honom i arrest, sa han i pausen.

# How Liberty Lobby and Arabs attempted to save defamer

Ditlieb Cluver-Felderer is the newest name for Amolek.

Remember him.

Last week he was found guilty in a Swedish court on charges of defaming the Jews and spreading the lie that the German Holocaust never happened.

He faces two years in jail.

Ordinarily, the 40 year old self-styled "Bible researcher" would not make a ripple in history for his odious crime.

But his trial brought out all sorts of rats from the woodwork.

The infamous Liberty Lobby of Willis Carto rushed to his side with telegrams of support.

The Carto sponsored Institute for Historical Review demanded an apology from the court on behalf of "the world of scholarship."

The anti-Jewish ugliness of the case brought out a telegram to the district attorney from Issa Nakhleh,

# The downfall of a Holocaust revisionist

chairman of the "Palestine Arab Delegation" and "advisor to the World Muslim Congress," who declared to Dr. Thorsten Jonsson, the Swedish prosecutor:

"I appeal to you to release Mr. Ditlieb Felderer (he misspelled the name, but no matter) from prison and stop these proceedings against him which are made because of instigation by Zionists in Sweden."

A panel of six judges in Stockholm heard the charges against Felderer for five hours.

They deliberated 10 minutes and came back with the verdict: "Guilty."

Handcuffs were slapped on Felderer in the courtroom and he was led off to jail.

But that's the tip of the iceberg.

Here's the Felderer story.

He was one of nine so-called "scholars" who were paraded by the Institute for Historical Review out of the publication's offices in Torrance as giving authority to the IHR thesis that the Holocaust was a hoax — "the hoax of the 20th century."

Others included former nazi officer Dr. Reinhard K. Buchner of Calstate University, Long Beach, and Dr. Arthur R. Butz of Northwestern University.

Felderer was the "Bible scholar" in the gaggle of IHR experts.

His *modus vivendi* was to send out leaflets to Jews and libraries under the imprint of "Jewish Information" in Taby, Sweden. The leaflets often would contain hair of animals or from wigs and the leaflets would declare that such hair was as real as the hair being displayed at the Holocaust Museum in Auschwitz.

"Jewish Information" in Taby was addressed in care of a "D. Cohen." Also a fake name.

When he directed his venom to Mel Mermelstein of Huntington Beach, a survivor of Auschwitz and other German death camps, Felderer met his nemesis.

It was Mermelstein who had filed a \$17 million suit against the Institute for Historical Review, the Liberty Lobby and a group of bigots who sought glory by revising history in order to revitalize the German Hitler cult.

Felderer distributed vile documents, including one called "Mel Mermelstein, the Trial of a Nut."

Felderer was irate at Mermelstein because the latter had won a ruling in Los Angeles Superior Court by Judge Thomas J. Johnson who had declared on Oct. 9, 1981, during one phase of the Mermelstein lawsuit, that "The court takes judicial notice of the fact that Jews were gassed at Auschwitz."

Further, said the court: "The Holocaust is not reasonably subject to dispute and it is capable of immediate and accurate determination by resort to sources of reasonably indisputable accuracy. It is simply a fact."

Mermelstein watched as his mother, father and sister were marched off into the gas chambers.

His bitterness against those who would rewrite history to downgrade the validity of the Holocaust brought out an implacable determination that the revisionists will never get away with it.

And so, as the Felderer trial was set in the Stockholm courtroom, Mermelstein was there as a witness.

Before Mermelstein's presence was announced, Felderer scornfully denied ever sending out any anti-Semitic leaflets.

The prosecutor asked: "Did you ever send any leaflets to Mr. Mel Mermelstein in California?"

Felderer shrugged, "I can't remember."

"If Mr. Mermelstein would appear in this courtroom, would your memory improve?"

Felderer paled.

Mel Mermelstein had gone to Sweden at his own expense, hired a Swedish attorney and came forth as a witness against Felderer.

For three of the five hours of testimony, Felderer spoke on his own behalf, tracing an ugly picture of Jewish claims to national martyrdom.

He faces a two year sentence under the laws of Sweden, which make it a criminal offense to make "statements or notifications which will be known in general and will threaten or express disrespect for people of a certain race, a certain color of skin, of a certain nationality or with a certain faith."

Persons convicted of these charges "will be sentenced for baiting against people to imprisonment..."

Felderer was ordered to undergo a mandatory psychiatric examination and may find release from prison to be a difficult road.

Felderer was part of the group that had offered a \$50,000 reward to anyone who could prove that Jews were gassed at Auschwitz.

## Who is Ditlieb Felderer?

✓ To the Liberty Lobby and to the Palestine Arab Delegation to the UN, he is an "unfettered scholar."

✓ To the court in Sweden he is a criminal who defamed Jews.

That's the subject of Mermelstein's lawsuit. The court's action in taking judicial notice of the fact of the Holocaust strips the gaggle of "scholars" bare.

In a letter to the Jerusalem Post, Felderer wrote in response to a note from Mermelstein, who warned that the "revisionists are at it again," that he (Felderer) had nothing to do with nazism, adding:

"Furthermore, my relations with the synagogue here (in Stockholm) are of the best and I have participated in the services, although not being a regular member. There is a cordial relationship between us."

To which Jan-Eric Levy, executive director of the Stockholm Jewish Community responded in the Jerusalem Post:

"To put the record straight, we would like to point out that Felderer is indeed running a campaign in Sweden through his obscure organization, Bible Researcher — denying the fact of the Holocaust.

"He is spreading leaflets in Swedish schools inciting pupils to ask their teachers about the 'truth' of the Holocaust, offering huge sums to persons who can prove they saw gas chambers, denying nazi atrocities and so on.

"Felderer has certainly no 'cordial' relationship with any synagogue in Stockholm. And furthermore, he has no good intentions in this matter. We urge your readers not to believe or trust the falsifications in Felderer's letter and not to help him in case he contacts them with obscure questionnaires."

Mermelstein says that Felderer conspired with the Liberty Lobby and the Institute for Historical Review to offer the \$50,000 reward for proof of the Holocaust as a "gimmick."

After watching Felderer being handcuffed by a Swedish jailer and led out of the courtroom, Mermelstein took the next plane home to America.

Another letter to the Jerusalem Post from a resident of Sweden (name withheld) declared that "Felderer is known as one of the biggest anti-Semites in Sweden ... he has translated German books of an extremely anti-Semitic nature. He has also harassed several prominent Jews.

"Felderer claims he is a good friend of Jews in Stockholm. To the best of my knowledge, he does not have a single Jewish friend in Stockholm and in fact the community has on several occasions tried to take him to court."

It was Mermelstein's testimony which convicted Felderer, according to Swedish newspaper reports.

Heritage was the first publication in the world to name the gaggle of scholars who supported the thesis that the Holocaust was a "hoax."

Mermelstein's dramatic court battle began.

During course of the action, Lewis Brandon, director of the Institute for Historical Review, resigned and it was revealed that he was operating under a false name. That his real name was David McCaulden.

Mermelstein called their bluff.

"I said, put your money where your mouth is," he told Heritage on his return from Stockholm. "They turned out to be hoaxsters, seeking publicity for themselves."

When it became clear that Felderer was in deep trouble in Sweden, the Washington-based Liberty Lobby wired the state prosecutor:

"Liberty Lobby, with its long standing concern for human rights and unfettered scholarship, is alarmed and shaken to learn of the arbitrary arrest of Dietlib (cq) Felderer and the seizure of his documents and files.

"Felderer is a well known scholar and original researcher in the field of contemporary history and a respected journalist.



"His pursuits surely cannot be considered criminal especially by the Swedish government with its world-wide prestige for lawful and democratic administration. We urge the release of Felderer ... so that we can support the defense of this distinguished young scholar."

The Liberty Lobby is one of the most notorious anti-Semitic organizations in the United States. The telegram was signed by Robert M. Bartell "chairman of the board."

The real boss of the Liberty Lobby is the elusive Willis Carto, who has been served in the Mermelstein court action.

During a visit to America last year, Felderer was also served as a defendant in the case.

In his telegram to the district attorney, Issa Nakhleh, who heads the Palestine Arab Delegation (to the UN?) threatened:

"If he is tried, I shall come to Sweden with other witnesses to expose the unjust political motivation behind this trial."

"I cannot imagine that such an injustice and political persecution can be made to silence a man who is trying to publish what he believes is true and to defend the right of the Palestinian people who have been subject to

**TYPICAL FELDERER LEAFLET** — Macabre item distributed by Dittlieb Felderer, an associate of the anti-Semitic Liberty Lobby in America, to Jews of Europe and the West. Felderer would glue hair to the "cartoon" to prove that the exhibit of hair of victims at Auschwitz is a collection of animal hair and not that of Jews who were gassed by the Germans. A copy of this leaflet was sent to Mel Mermelstein. Based largely on his testimony, Felderer was convicted in Sweden last week on charges of defamation. He faces a two-year prison sentence.

Zionists' war crimes and crimes against humanity."

Tom Marcellus, current director for the revisionist Institute for Historical Review, denounced the arrest of Felderer also in the following telegram to Prosecutor Jonsson:

"News of barbaric arrest without charges of Dittlieb Felderer, a courageous scholar, the very embodiment of freedom of inquiry and speech, whose reputation is well known and respected in the U.S., received. # Rashetsåtalade mannen ska sinnesundersökas

**Den 40-åring från Täby som rannsakades för hets mot folkgrupp på måndagen ska genomgå stor rättspsykiatrisk undersökning. Det beslöt Södra Roslags tingsrätt efter att ha slagit fast att mannens skuld blev tillräckligt starkt bevisad under rättegången.**

Mannen ska stanna kvar i häktet i avvaktan på den psykiatriska undersökningen, eftersom det är risk för att han annars fortsätter sin rashetsande verksamhet.

Länsåklagare Torsten Jonsson valde att åtala mannen för ett tjugotal flygblad med judefientlig propaganda, som mannen försett med påtejpade hårtussar, tvålbitar och till synes använda kondomer.

De på detta sätt utstyrda skrifterna har mannen sänt till judiska organisationer och till enskilda judar i en mängd länder i västvärlden. Svenska diplomatiska beskickningar i flera länder har vidarebefordrat protester, och Västtyskland har via de diplomatiska kanalerna bett Sverige överta lagföringen av mannen.

40-åringen vägrade att ge raka svar på de flesta punkterna i åklagarens sakframställning. Några enkla ja eller nej ville han inte gå med på, och domarens tålmod sattes på svåra prov. Mannen ville inte i något av de fall åklagaren förde fram erkän-

na att det var han som skickat breven, tejpade hårtussar och tvålbitar, eller skrivit kommentarer för hand.

40-åringen är född i Österrike och båda hans föräldrar är judar. Fadern dog av svält, modern och sonen överlevde och kom till slut till Sverige 1949. Mannen berättade att han utsattes för förföljelse i skolan och blev något av en enstöring. I början av 1970-talet uteslöts han ur Jehovas vittnen, sedan han ifrågasatt om det verkligen var sant att tiotusentals vittnen gasades ihjäl i Tyskland under andra världskriget.

## Bekämpar Israel

Sedan dess har 40-åringen ägnat all sin tid åt att bekämpa det han kallar sionismen. Därmed menar han staten Israel och förmodligen också nästan samtliga judar i världen, även om han säger sig inte erkänna judar som en folkgrupp. Koncentrationslägren

har inte existerat som annat än rekreationsläger, som vilohem med hästkapplöpning, swimmingpooler och andra bekvämligheter, berättade mannen för en häpen tingsrätt.

Koncentrationslägren och gaskamrarna är en uppfinning av den internationella sionismen för att rättfärdiga utrotningen av palestinierna, påstod den åtalade.

40-åringen säger sig ha levt helt på lönen som extra bussförare varannan veckohelg. Han har dock haft råd att åka till USA och Polen flera gånger de senaste åren. I hans bostad fann åklagaren mängder av dyrbar utrustning bl a komplett kontorsoffset. Åklagaren anser att mannen haft starkt ekonomiskt stöd, annars skulle det ha varit omöjligt för honom att trycka och sprida så mycket skrifter och flygblad.

Den åtalade fick gott om tid av domaren att berätta om innebörd och bakgrund till den propaganda han nu drivit i flera år. Han

vände sig mer till åhörarna än till rätten i det som snarast blev ett propagandatäl.

## Historieändring

40-åringen räknar sig tillhöra ett internationellt sällskap av "revisionister", som söker ändra den historiska bilden av judeförföljelserna i Hitler-Tyskland.

Ett vittne som den åtalade inte ville höra fanns i salen, en man som kunde berätta hur det var i koncentrationslägren. Mel Mermelstein, nu bosatt i USA, fördes till Auschwitz den 21 maj 1944 som 17-åring. Han ensam överlevde, hans föräldrar och syskon utplånades. Också till honom har den åtalade skickat skrifter, flygblad, hårtussar och tvålbitar. Mermelstein kommer att väcka talan mot mannen senare.

JK:s beslut om tryckfrihetsåtal mot innehållet i mannens skrifter väntas i mellandagarna.
