Complimented though I was by your reference to my "indispensability" in connection with the CASSIDY SKIT at the Ball, I feel impelled to be on record with you as to the following.

I respect and understand your dedication and determination, but I am not quite so sanguine as you are about the ease of replacing Bronek and Zubin for this particular chore. I'm not saying that they cannot be adequately replaced; I am saying two other things:-

- a) I definitely do not have the time to become involved in a telephone campaign/ search.
- b) Doing the skit with Bronek and Zubin would not only have been large fun for me, it would have been, with them, a lead-pipe cinch to prepare, rehearse and perform.

I know I can stand on my long record of being faithful and never a backer-outer. But, Henri, in view of the enormous pressures of my many commitments and the round-the-clock work and concentration therewith involved, I just cannot allow my obligation to you to become "Mount Everest". I'm going to have to depend on you, Henri, to come up with the replacements, and those replacements will have to be fine for the job in my judgment. This skit can either be hilarious, tasteful and gracious or it can be equally dull, clumsy and tactless, depending on the performing ability and personalities of the "cast". It is only fair to tell you now, Henri, that, in terms of all the foregoing, there is a chance that I may not be able to do it.
