Given the organization's finances, I have been instructed by Mr. Harry Dapeer, Treasurer, to offer you an honorarium of \$ 100.00 per rehearsal, for a total of \$ 200.00. Obviously, this is not intended as a fee, only as a token of the orchestra's recognition of your invaluable assistance.
