I have anxiously been awaiting your return this past week to bring to your attention a matter of the utmost seriousness and urgency. Last month George Appleton, in the presence of Gerald Daniel and myself, made a firm commitment to bring Jean Pierre Rampal, the great French flautist, to this campus in March 1973 for 2 master classes at a total cost of \$1,000. It was only possible to obtain this favorable contract because of the fact that I am already bringing Rampal to Los Angeles during that week. Mr. Appleton also asked me to investigate the possibility of having Rampal give a concert on the campus, and the terms. I phoned Rampal's agent in New York (incidentally, at my own expense) and was able to obtain terms of \$1500. for a recital, out of which Mr. Rampal would pay for his own accompanist. Considering Rampal's extraordinary drawing power, this is a low fee.

I had a second meeting with Mr. Appleton in the course of which he asked me to finalize the master classes and the concert and requested that Mr. Rampal's agent send him a contract. I understand that Mr. Appleton now disputes these facts, but I want to make it very plain that I would not have instructed Mr. Rampal's agent to make out a contract unless I was sure that Mr. Appleton had made an unequivocal commitment. To my profound shock I received a call from Mr. Rampal's agent on the morning of March 27 advising me that Mr. Appleton had returned the contract unsigned and cancelled the entire commitment. Mr. Appleton had not even advised or consulted me.

I wish to express my profound outrage. In my profession a man's word is his bond. I will not be placed in so dishonorable position, nor be so deeply embarrassed, as a reward for my efforts. Furthermore, it is incomprehensible to me that our college would forego so extraordinary an opportunity. I have called Mr. Rampal's agent to assure her that the commitment I made on behalf of the college will be honored. I urgently request an immediate meeting with you, before the opportunity of bringing Mr. Rampal to his campus is irretrievably lost.
