## "Language Barriers to Justice" Forum on April 24

**EVENT:** Language Barriers to Justice in California, a forum-style discussion by five distinguished California judges. The discussion will be based on a report recently issued by the California Commission on Access to Justice, which found that lack of funding and qualified interpreters limits access to justice for nearly 7 million Californians who need language assistance in the courts. The report points out that Californians speak more than 220 languages, and more than 40 percent of the population speaks a language other than English in the home. The goal of this forum is to focus attention on this challenging situation. The event is presented by the California Commission on Access to Justice and the Chapman University School of Law.

**BACKGROUND:** The California Commission on Access to Justice is a 24-member body of lawyers, judges, and academic, business, labor and community leaders whose mandate is to explore ways to improve access to civil justice for Californians living on low and moderate incomes. The commission was instrumental in establishing the \$10 million Equal Access Fund for civil legal services to the indigent, and works closely with the State Bar and Judicial Council to improve access to the courts.
